- 2 Subscriptions are per person, are none transferable and <u>NOT</u> per horse. A non-subscriber riding a subscriber's horse will be asked to pay a Visitor Cap.
- 3 Point-to-Point Subscriptions: Please apply to the Hon Sec for further details.
- 4 Insurance. All those who go out hunting should, in their own best interests, be insured against third party liability; see 8 below in relation to the cover provided by Countryside Alliance membership.
- 5 Liability. By coming out hunting, you agree to the terms of the Hunt's constitution, which provides that neither the Hunt, nor any of the Masters or officials/employees of the Hunt, or other persons engaged in the activities of the Hunt, shall have any liability to you in relation to anything arising from the activities of the Hunt, whether or not arising from negligence (save as mandated by law), and you agree not to bring any claim against such persons or the Hunt (save as mandated by law).
- 6 Dress. Subscribers are expected to come out in correct hunting dress. Only Masters, former Masters, Hunt Staff and Hunt Secretaries may wear a black cap with a scarlet coat. Anyone else wearing a scarlet coat must wear a grey cap. Safety headwear is acceptable providing the correct colour is used.
- 7 Meet Cards. All subscribers will automatically be sent meet cards providing the correct payments have been made.
- 8 Countryside Alliance membership. It is expected that ALL subscribers and supporters be current paid-up members of the Countryside Alliance; membership currently provides cover against third party liability.
